





# 2010-14 SVE Smooth Deck Lid Panel

## STEP 1: REMOVE FACTORY MEDALLION/DECK LID

- From the factory, deck lids and medallions are held on by double-sided adhesive as well as
  plastic clips. Carefully use a plastic pry tool to start lifting up a section of the emblem. You may
  also use fishing line to help make the initial cut through the adhesive however, keep in mind that
  the line will not be able to go fully through the emblem due to the studs on the back.
- Once you have the emblem lifted up enough, pry the rest of the medallion off to fully remove it from the trunk lid.

# **STEP 2: CUT HOLE TO SMOOTH AREA**

- To ensure there is enough tape to cover the hole you will be cutting, you can use the provided tape as a template for guidelines before cutting. *(Do NOT peel and stick the tape at this time)*
- Using a cutting tool such as a Dremel, trim around the raised surface of the deck lid to make sure the area is as flat as possible.

### **STEP 3: INSTALL TAPE**

- After the hole is cut, use isopropyl alcohol and a microfiber tower to clean the area. Once cleaned, we suggest cleaning up any burs and using touch-up paint to coat the cut surfaces to prevent rust.
- Install the provided tape to cover the hole and any other areas left open to prevent dirt, debris, and water from entering the trunk.

# **STEP 4: DECK LID INSTALLATION**

- Now that the tape has been placed and the deck lid area is smoothed out, take your microfiber towel and isopropyl alcohol once more and thoroughly wipe the deck lid clean. Prep is key in promoting proper adhesion of the double-sided tape.
- Take this time to add any additional double-sided tape to the backside of the deck lid for an even stronger hold if desired. (Additional tape is not included)
- Remove the backing of the double-sided tape and carefully line up the deck lid to the trunk.
   Once the alignment is good, press and hold the deck lid in place for at least 30 seconds with firm pressure. This will give the tape time to adhere.
- Wipe down any smudges on the deck lid that may be present from installation.
